Draft Minutes of the Board of Supervisors of the Pima Natural Resource Conservation District (PNRCD)

Telephonic Meeting Date: June 14, 2022

Time the meeting was called to order: 1:00 pm

Supervisors-Clerk: Jim Chilton, Cindy Coping, Jonathan DuHamel, Patricia King,

Andrew McGibbon, and Liz Tuck (Clerk). A quorum was present.

Review/approve invoice for Employee Dishonesty Bond

Motion: Supervisor King moved to approve the payment of \$359.00. Supervisor Coping seconded the motion. The motion passed unanimously 5-0.

<u>Discuss/Approve payment of \$135.00 for Liz Tuck to enroll in a website development course.</u> After discussion, item was tabled.

Discuss/Approve Payment for the Education Center Director to attend the annual AACD conference on August 4th and 5th. Cost for registration (\$100.00) and hotel (\$192.00) is a total of \$292.00.

Motion: Supervisor Coping moved to approve the expense and Supervisor McGibbon seconded. Chairman Chilton moved to expand the motion to include reimbursement of any supervisor that attended. Motion carried 5-0.

Supervisor Coping said she wanted to attend. The clerk will send the conference announcement to all supervisors.

Discuss/Approve Annual Workplan for Pima NRCD.

Changes: add Resource Assessment to the list of priorities; add Allocation of Water Resources to list of workshop topics.

Motion: Supervisor Coping moved to approve the Annual Work Plan as revised. Supervisor McGibbon seconded the motion. Motion carried 5-0.

Discuss/Approve Annual Workplan for Pima Center for Conservation Education. The priority for fiscal year 2023 is the development of a website, which will include videos and articles of interest to Cooperators and the public. The website will be separate from the Pima NRCD website but will be a subdomain of that site. This reduces the cost of hosting the site. A budget of \$5,000.00 was set. The Center Director will apply for grants to increase funding for the site.

Motion: Supervisor Coping moved to approve the Annual Work Plan as revised. Supervisor McGibbon seconded the motion. Motion carried 5-0.

Discuss/Approve budget requests for Fiscal Year 2023.

Motion: Supervisor Coping moved to approve the budget requests for the same funding levels that were submitted in the previous year. Supervisor McGibbon seconded the motion. Motion carried 5-0.
