Financial Report highlights by Treasurer Coping

- Opened a brokerage account for the Pima Ed Center, \$27,275 transferred from Hughes and invested per portfolio allocation approved by the PNRCD/ PCCE Board of Supervisors (on 1/21/25
- Sold all PNRCD foreign investments for realized capital gain of \$11,902.83
- Re-allocated PNRCD target brokerage portfolio to all-domestic securities per strategy approved by PNRCD/ PCCE Board of Supervisors on 1/21/25
- Market volatility caused unrealized capital losses in both the Pima NRCD and PCCE brokerage accounts but no capital losses were realized.

• Portfolios were re-balanced occasionally to target allocations \$7613.99 remains in Hughes Ed Center checking account State account holds \$9018.34 in Hughes checking District account all domestic now \$119,000 as of 4/22/2025

grows to more than \$50,000, then filing a full form 990 would be required.

Supervisor DuHamel asked what the tax consequences are of the realized capital gains Since Pima NRCD is a government entity, no related tax reporting Ed Center is a 501c(3) -an annual Form 990N is filed electronically after the end of the fiscal year. The filing is a very simple confirmation that PCCE received less than \$50k annual income. If annual income

Old Business

Rancho Seco project update by AVCA, Elena Dosamante, see attached. The solar pump and tanks are now installed. Plumbing to connect them to drinkers still needs to be installed.

Workshop series update by AVCA, Elena Dosamante. Two workshops are complete, with two to go. 50 people (including 3 staff and 14 presenters) attended the first workshop. Forty nine people including 3 AVCA staff and 9 presenters attended the second workshop. So far, 25 people and 9 presenters have signed up to attend the third workshop.

The upcoming technology workshop has many speakers, so AVCA would like to propose doing two more workshops in the fall, at a \$1,875.00 per workshop cost for each workshop. See attached proposal.

PCCE budgeted \$10116 for the 2025 fiscal year, committed \$7500.00 for the four AVCA workshops, and have \$2,600.00 remaining uncommitted budget. Fall 2025 is FY 2026 so plenty of funding is available for two additional workshops.

Motion by Supervisor Coping to pay for 2 workshops for fall 2025 from combination Ed Center funds and/ District funds at cost of \$1,875 per workshop, consistent with existing agreement with AVCA 2nd by Supervisor DuHamel. 4 in favor, Miller recused. The first workshop is already organized to focus on technology and is titled, "Introduction to Remote Sensing and GIS Technologies." See attached proposal. The 2nd topic is open. The AVCA and Pima NRCD will sign an addendum to the existing agreement, to include the two fall workshops.

The second workshop hasn't been set and the AVCA requested suggested topics. Supervisor McGibbon suggested possible topic related to insurance / wildfire / prevention / clear guidelines for people living in rural areas about fire prevention practices — maybe fire prevention / preparedness / interact with wildland /urban interface. Bring in insurance companies? Pima and Santa Cruz Counties? Insurability against fire? Collaboration with Santa Cruz or other NRCD? Fire Districts? Improving insurability? It is such a big topic that it is putting big money into mesquite cleaning? State DFFM? FS more engaged? FS Madiera Canyon to use managed grazing to reduce fuels in Madera Canyon. Lots of interest in targeted grazing at previous workshops ... also angles of fire in relation to flooding ... a bit more of the business / fire prevention / policy / tools / managed grazing. Tie to Commercial Real Estate world in relation to invasive species and fire danger. Interplay between grazing policy / fire risk ... management of fuels. Key to get FIRE DISTRICTS?

Monarch butterfly: No activity

Clerk / facilitation:

Supervisor Miller brought a proposal from Southwest Decision Resources (SDR)to provide support to Pima NRCD, see attached.

Supervisor Coping said, if we don't do something different we won't have different results

Supervisor Chilton doesn't want to reject it, but does want to limit it.

Supervisor McGibbon stated that the reality is that most of the money we have invested has been just sitting doing nothing. If we need to use some money to get organized and helps get new faces on the board, it is reasonable.

Chair McGibbon asked for a motion to hire SDR to do 75 hours of clerical support for one year for \$8,500. **Motion** by Supervisor Miller, 2nd by Supervisor Coping, **All in favor.** Supervisor Miller and Supervisor Coping will meet with Southwest Decision Resources to develop a contract

FARM BILL PROGRAM UPDATES:

- Federal Fiscal Year 2025 (FY25) started October 1, 2024.
- Application deadlines for FY25 funding have passed. Now processing applications.
- Eligibility Deadline for General EQIP has now passed.
- CSP Eligibility was March 28th, and the cost estimate and ranking deadline is July 11th
- Cost Estimates and Ranking Deadline for General EQIP is April 28th, 2025
- Still operating under 2018 Farm Bill.

NRCS FUNDING PROGRAMS – (FY25 Allocations):

There have been no funds allocated for this Fiscal Year for our programs. We are hoping to find out soon how much funding Team 7 will receive for each program.

- CSP Conservation Stewardship Program
 - Assists producers that already have a conservation plan they are maintaining.
 Provides financial assistance to enhance existing systems.

- EQIP Inflation Reduction Act (IRA) funds available statewide
 - Funding through the IRA will provide direct climate mitigation benefits
 - IRA funding limited to specific Climate Smart Mitigation Activities

 - Was given the go ahead to move forward with payments for active IRA contracts but cannot obligate any new contracts. This is still on hold by National
- EQIP Environmental Quality Incentives Program funding
 - Provides technical and financial assistance to agricultural producers. Helps with funding of projects on operations to improve the natural resources and management of the land.

- Joint Chiefs Catalina Rincon: Mount Lemmon watershed area
 - The Joint Chiefs' Landscape Restoration Partnership enables NRCS and the Forest Service to collaborate with states, agricultural producers, forest landowners, tribes and public land managers to invest in conservation and restoration at a big enough scale to make a positive difference. Working in partnership, and at this scale, helps reduce wildfire threats to communities, protect water quality and supply, and improve wildlife habitat for at-risk species.



FALL 2025 RANGELAND RESILIENCE WORKSHOP

In Partnership with Pima Natural Resource Conservation District

The purpose of the Rangeland Resilience Workshop Series workshops build resilience in rangelands by providing ranchers and other rangeland managers with a broad selection of tools that will help them face the different challenges that come with managing rangelands in the Altar Valley, Pima County, and other similar ecosystems.

The Altar Valley Conservation Alliance (AVCA) would like to propose Pima Natural Resource Conservation District continued partnership to work on extending the Spring 2025 Rangeland Resilience Workshop Series into the Fall 2025, with the possibility of extending into Spring and Fall 2026. AVCA estimates approximately \$1,875 of required funding per workshop. This estimated cost includes staff time for planning and preparing the workshop, staff time for facilitating the workshop, lunch, snacks, refreshments, name tags, and printed materials.

OBJECTIVES:

- Host two full-day educational workshops on rangeland tools in Fall 2025.
- Provide actionable tools and available resources to rangeland managers.
- Encourage collaboration between ranchers, universities, nonprofit organizations, and government agencies.

PROPOSED WORKSHOP: INTRODUCTION TO REMOTE SENSING & GIS TECHNOLOGIES

There is a pressing need to develop methodologies and data collection systems at the local, regional, and national levels to monitor and assess rangelands that would supplement current field data collection techniques. Field methodologies have been refined and improved over the years, including using the latest mobile data collection devices and software, however, with the amount of land under management and limited resources available, remote sensing is being increasingly integrated into Natural Resource programs. Remote sensing and Geographical Information System (GIS) technologies increasingly offer opportunities to generate synoptic, high-resolution characterizations of ecosites in heterogeneous and remote rangelands.

The goal of this workshop is to introduce rangeland managers and ranchers to basic concepts and useful remote sensing and GIS applications that can help detect vegetative cover patterns occurring on the landscape.

WORKSHOP OBJECTIVES:

- Learn about remote sensing and GIS based technologies directly from the experts and developers.
- Provide participants with the opportunity to connect with developers and experts in the field of remote sensing and GIS applications.
- Provide space for real-time and hands-on demonstrations.
- Plan and discuss how remote sensing and GIS based technologies can be used to improve current management practices.

Southwest Decision Resources - Facilitation Support Estimate (April 2025)

<u>Southwest Decision Resource</u> (SDR), founded in 2004, is a Tucson-based team of facilitation and collaboration professionals committed to more informed and inclusive planning and decision making on public lands and natural resource issues. We work together with our partners to support the development of successful and efficient teams that achieve effective, high quality outcomes.

SDR has worked on ranching and agriculture issues in Arizona over the past 20 years. These include:

- Work with NRCDs: Strategic planning with Pima NRCD (2014); Winkelman NRCD involvement in the Lower San Pedro Collaborative (facilitated by SDR); Verde NRCD involvement in the Verde Watershed Restoration Coalition (previously facilitated by SDR)
- Altar Valley Conservation Alliance: SDR facilitates watershed restoration planning, including rangeland issues, over the past 10 years. SDR also facilitated AVCA's strategic planning process.
- BLM Las Cienegas National Conservation Area adaptive management: SDR has supported this rangeland based collaborative effort for the past 15 years.
- Kingman Grazing Allotment SDR facilitated the development of a contentious grazing allotment renewal process, through a grazing subcommittee of the BLM Resource Advisory Council.
- Agriculture and grazing partners are part of many of the processes we facilitate.

SDR would provide strategic planning and coordination services to the Pima NRCD Board. Tailored to the specific needs of the board, support would include a team of two facilitators to conduct:

Annual facilitation and coordination support - Amount: ~\$8,500/yr (Total hours: 75)

- Scheduling, documentation and website management
- Agenda design, facilitation and notetaking of quarterly board meetings (in-person, 4/yr)
- Interim check-in/planning meetings (virtual, 2/yr)

Note: After the first year we would transition to one facilitator supporting the board, reducing costs.

Strategic planning and design - Amount: ~\$7,000 (Total hours: 45)

Strategic planning support would help to develop board capacity, review and refine board objectives, identify potential new members and assess cooperator engagement.

- Initial meetings with board to identify scope and objectives
- Assessment interviews with board members, and assess coordination with AACD and other NRCDs
- Design, facilitation and notetaking of strategic planning half-day retreat
- Path forward meeting to identify next steps
- Optional Cooperator management: Assess current communication and coordination with cooperators. Identify needed improvements and develop processes to implement (Hours/cost TBD based on scope and need)
